Troy Peyerk Report -

Troy Peyerk reported that the Spring 2025 count is estimated at 32. Juvenile = 22.

Jail = 10.

Troy reported that SCCIA is going to continue to track weekly jail-side numbers for the remainder of the year.

Mike McMillan commented that there might be a way for the county to help with a juvenile side teacher (detention).

Troy commented that we need to have at least 10 to 12 per class. Mike McMillan commented that they will have up to 20 students in the new detention unit, and up to 36 enrolled in DTNW. That would be up to 12 in a classroom.

Troy commented that education for students in the detention program will look a little different.

Troy reported that he had to put together a drinking management water plan. The fountain in the gym has to be modified. All non-consumptive water sources have to be labeled. The kitchen needs to be filtered as well. Tracy Eschenburg said that some filtered faucets need to have an indicator light.

Amy Townsend Report -

Amy Townsend said that she and the teachers are getting to know the new students and the school is preparing for state testing that is coming in the April.

The teachers and DTNW staff are continually working on implementing incentives to increase student attendance.

Mike McMillan reported that Tom Hull has left his position with the juvenile court and started a new county position. Mike said he posted for Tom's position and the posting has now closed.

They are also looking at staffing for the new detention center. Mike informed the Board that they are waiting on fire and safety inspections.

Monika Weaver commented that staff are ready to hit the ground when the new facility is ready.

Mike McMillan suggested that the teacher for the detention center could be funded out of the county's child care grant to help make up the difference because of the low initial count.
